DATA COLLECTION

Fieldwork Experience

· Nepal (August - September 2019)

Conducted over 40 Semi-structured Elite Interviews with security personnel (active and retired), former rebels, government officials, NGO representatives, journalists, and activists in Kathmandu.

Datasets (Completed)

· Post-Regime Change Trials (PRCT), with Louis Pascarella [Link]

Identifies all formal prosecutions undertaken against former government officials in the wake of a regime death, 1974-2010. Critically, the PRCT provides information about the quality of prosecutions, assessing them to be either free and fair or flawed. These data are temporarily embargoed, but may be shared upon request.

· Nonviolent and Violent Campaigns and Outcomes 2.1, with Erica Chenoweth [Link]

Identifies and tracks over 380 violent insurgencies and nonviolent mass movements, 1945-2013. Campaign attributes like participation size, institutionalization, and government repression are provided at the campaign-year level.

· Social and Economic Rights (SERF) Index (2023 update, 2022 update), with Susan Randolph [Link]

The SERF index relies on economic development data to measure states' efforts to provide six fundamental social and economic rights to citizens (e.g., the rights to food, shelter, and healthcare) for all countries, 1997-2021. Critically, scores are assessed with reference to states' capabilities. SERF scores therefore show when and whether states effectively leverage available resources to fulfill their obligations. SERF scores are expanded and fully updated annually.

· Emotive Events Database (EED), with John Gledhill and Allard Duursma [Link]

The EED adds three new variables to a subset of NAVCO 2.1 (all nonviolent campaign-years, 1985-2013), quantifying the prevalence of 'emotive events' organized by campaigns on a yearly basis. These tactics (e.g., concerts, plays, and mass singing) evince positive emotions in participants who are physically present.

Datasets (In Progress)

· Nonviolent and Violent Campaigns and Outcomes 2.2, with Erica Chenoweth

Significantly builds on previous iterations of NAVCO, primarily by expanding the study period from 1945-2013 to 1945-2020. Campaign attributes like participation size, institutionalization, and government repression will be provided at the campaign-year level.
